The purpose/objectives/goals of the Centre/Institute

The Global Development Institute (GDI) was established at the University of the Fraser Valley to create collaborative global partnerships to support international development activities and provide students with new learning opportunities in Canada and around the globe. The Institute is involved in the planning, execution, monitoring and evaluation of community and international development and institutional capacity building projects. Its research addresses many of the key issues relating to community development and institution building. The following four areas have been adopted as priorities for the work of the Institute: good governance and rule of law; children and development; environmentally sustainable development practices; and education. Activities of the Institute are interdisciplinary, student focused, apply evidence based approaches and are committed to the promotion of human rights.

Membership and governance of the Centre

The governance of the Global Development Institute is managed by the Director and the management committee comprised of the Institute's membership which provides oversight to ensure transparency and accountability. The director is appointed by the AVP Research, Engagement and Graduate Studies. The management committee provides advice and guidance on the Institute's activities, programs, strategic planning and plans for seeking funding for research activities. Relevance of activities to the community

- October 2014: Dr. Edward Akuffo collaborated with Dr. Hamish Telford (political science department) and Dr. Scott Sheffield (history department) to host a roundtable discussion of the October 22, 2014 Parliament Hill gun attack. The event was widely publicized by the UFV and Star 98.3 FM and was very well attended by students, staff, faculty and the general public.
- April 2015: Dr. Edward Akuffo was invited to present a paper at a symposium on "
 The Regional Dynamics of Peace and Security in West Africa" that was jointly organized by the West Africa Institute, University of Portsmouth, Center for European Integration Studies, and Universite du Quebec a Montreal and held at the Kofi Annan International Peacekeeping Training Center in Accra, Ghana on April 28-30, 2015. Akuffo's paper was titled, "On Terrorism, Mali Conflict, and International Response: A Paradigm Shift or Perpetuating Hegemony?" The paper was very well received at the symposium and as a result of that he was invited by Emmnuel K. Bensah, the host of the Africa in Focus programme on Radio XYZ, a local FM station in Ghana to participate as a panelist in the one year anniversary of the programme which focused on the security and economic implications of illegal migration from Africa to Europe via the Mediterranean sea.
- May 2015: Cherie Enns and Dr. Garry Fehr were involved in the Sustainable Food Systems Symposium two days of fieldtrips; four workshops; and a public forum May 5-7th. Plans for the coming year

Associates of the institute will be strongly encouraged to generate several research proposals and expand the scope of the Institute's activities. Potential external funding agencies include SSHRC, IDRC and other local sources.

Dr. Edward Akuffo and Dr. Garry Fehr will be applying for SSHRC Insight Grants in October 2015. Akuffo's research focuses Canada's multilateral strategy on the African continent. Fehr will continue to work on Sustainable Food Systems with Aga Khan University (1.5 years remaining); the Importance of Seasonal Agricultural Labour in the Fraser Valley (one year beginning September 2015) – will hire at least one student; and diversifying the Agri-Food Economy in Punjab (three year project beginning January 2016). He plans to hire three students in partnership with UFV Chandigarh, The Centre for Indo-Canadian Studies and Panjab University.

Scott Lukasek, who was a co-op student at the UFV International, helped revamp the Institute's website. He was recommended by Chelsea Laird (UFV International) and we

want to take this opportunity to thank Chelsea and Scott. There is still some work to be done on the website and we will use the next reporting year to complete that work.

The institute also plans to re-launch its lecture series in the coming year.

The institute will pursue the MOUs it has initiated between the UFV and the University of Ghana and Kwame Nkrumah University of Science and Technology.
