# 2.1 South Asian Studies Institute (SASI) – presented by Satwinder Bains

- SASI's mandate is focused on conducting and disseminating research with a goal to
  address the community's needs and challenges, to affect and influence strategies in the
  development of government policy, and to restore the Canadian public record.
- SASI has applied to over 74 funding sources.
- SASI has the Canada India Studies Certificate, which is comprised of 32 courses across seven disciplines, with six faculty members.
- SASI is involved in multiple activities including community engagement, exhibit curation, awards and recognition, and media responses.

#### 3.2 How to identify potential student research assistants

- Teaching has changed with COVID-19 and it has become challenging to find students for research assistant positions due to teaching online and restrictions on in-person interactions.
- There is concern that students are not having equal opportunity. There was a question of how researchers can be fair to the student body and not just favour students who come forward.
- The Council brainstormed on how to connect with students and find research assistants.
- Some had success in the past by going to the Student Union and having them promote information on their social media platforms.
- Others have had students contact them through their research/biography webpages.
   Also, there has been success by using student associations, student networks (word of mouth) and asking professors to promote opportunities in their classes.
- Students tend to get involved in research in their fourth year. The information needs to get out to students in their first or second year so they do not miss out.
- Some areas have had success in having department emails sent out to students at the beginning and end of semester with different research opportunities.
- Having a faculty research panel where members speak for five minutes about their research can help get the information out there. Students can then have the opportunity to ask questions about faculty research and student involvement.

# **Transforming Research: UFV Strategic Research Planning 2020**

"From the vantage point of the colonized, a position from which I write, and choose to privilege, the term 'research' is inextricably linked to European imperialism and colonialism. The word itself, 'research', is probably one of the dirtiest words in the indigenous world's vocabulary." Linda Tuhiwai Smith

# **Background**

Universities engage in strategic research planning for a host of reasons. First, key federal councils require that applications for infrastructure funding and research chairs be tied to institutional strategic plans. This, to some degree, dictates the types of content these plans contain. These plans can also help to create a roadmap to where a university wants to go with respect to research, and a blueprint for who we want to be.

Equally as important is the process of consultation and planning. This process allows us to come together and ask the exciting and the hard questions. Where have we been? What have we achieved? Where do we want to go? What are the challenges and barriers? What are the opportunities? With the expiration of our 2016 Strategic Research Plan, we now have the opportunity and responsibility to take on this work.

Central to this process is indigenization of our plan and of research at UFV. Not done mindfully, indigenization efforts can function to segment indigenous peoples, epistemologies, pedagogies and worldviews. We will seek to engage this process in a way that is meaningful and embedded, identifying concrete, measurable steps toward Indigenization.

Also central to the consultation and the resulting plan is UFV's commitment to equity, diversity, and inclusion.

**Agenda Item 3.3 -** Online discussion on systemic racism in Canada's health research funding system – open until April 9, 2021

On December 17, 2020, CIHR published a message from the Vice-President, Research Programs entitled Online discussion on systemic racism in Canada's health research funding system.

We are pleased to inform you that the online discussion has launched and will be open until April 9, 2021. The content for the online discussion was developed in consultation with racialized and Indigenous researchers and stakeholder organizations. CIHR specifically invites the engagement of racialized and Indigenous communities with lived experience of systemic racism in the health research sector although the online discussion is open to all.

To participate in the online discussion, we invite individuals to visit the <u>Let's Talk CIHR</u> webpage, click on "REGISTER to get involved", and follow the prompts to register for and join the online discussion.

Additionally, starting in spring/summer 2021, we will hold virtual small group listening sessions with racialized communities on systemic racism in the health research funding system that will build upon themes and suggestions from the online discussion. These sessions will be codesigned with and moderated by racialized communities.

We will also hold dedicated engagement activities with Indigenous communities to discuss how CIHR can supplement our <u>action plan</u> to build a healthier future for First Nations, Inuit, and Métis Peoples in a way that further recognizes and addresses systemic racism. We will share more details about these dedicated engagements in the near future. In the meantime, we also welcome Indigenous communities to participate in the current broader online discussion about systemic racism in Canada's health research funding system.
