### Information

How does it work? Select the meal plan that suits your appetite, and savings. Meal plans are prepaid by adding money onto your Campus Card and operate as a declining balance. Meal plans are only valid for the time specified below. To be eligible you must have a Campus Card and be registered as a student in the current semester. ### Terms and Conditions

- **Validation:** meal plans are only valid for the time specified (please see chart above) to be eligible for the 5% GST tax exemption, and to comply with the Canada Revenue Agency (CRA) tax exemption guidelines.
- **Participating retailers:** Cascade café, Tim Hortons (Abbotsford), and the Road Runner café.
- **Campus Cards:** are non-transferrable, picture identification must match the person presenting the card, and only the card holder is authorized to use the funds and services on the card. There are no exceptions.
- **Alcohol:** meal plans cannot be used to purchase alcohol on campus.
- **Purchased amounts:** CRA requires meal plans to be purchased in one lump sum; during the semester while the purchased meal plan is valid you cannot transfer any portion of the meal plan balance to another card fund, nor can you “top up” the meal plan amount.
- **Prorated:** meal plans cannot be prorated throughout the semester.
- **Changed your mind:** no worries, funds will be transferred into the Cascade account and can be used at any participating retailer on campus; however, 5% GST applies. No admin fees are charged when changes are made within the first two weeks of classes. After two weeks, a \$25.00 admin fee applies to move the meal plan into the Cascade account. Refunds are not available unless you are withdrawing from UFV (please see “Refunds” below).
- **Remaining balances:** at the end of the semester meal plan balances of less than \$25.00 are forfeited; balances greater than \$25.00 will be charged a \$25.00 admin fee to transfer amounts into the Cascade fund; Cascade dollars can be used at any participating retailer on campus (5% GST applies). Cascade accounts that are inactive for six months or more are charged a \$25.00 admin fee. Admin fees apply every six months thereafter to accounts that are inactive until the fund balance reaches zero. Depleted accounts will be closed.
- **Refunds:** are only issued to students who withdraw from UFV, a \$25.00 admin fee will be charged to process a refund; refunds are issued to the card holder only and take approx. 4 to 6 weeks to process. Please see the Campus Card office for more information.
- **Lost card:** report lost cards to the Campus Card office immediately; you are responsible for all transactions on the card until it is reported, a replacement fee of \$10.00 applies for lost, stolen or damaged cards prior to the expiry date on the front of the card (prices subject to change).
