6.2 External Advising Review

- Report was circulated

Recommendation options from the review include:

- A central advising structure, whereas the students will go to Student Services and be overseen by the VP Students OR
- Keep current advising models but students with 0-60 credits be advised by Student Services
- Lucy received some comments from Department Heads
- Strong feedback was received from faculty and students in favor of the current advising system.
- Concern was raised regarding the recommendations because of the certificate and diploma programs. The students would benefit by receiving advice from a Science advisor
- Science Advising group is quite important to the Science model and would recommend that the advisors remain as voting members of the Faculty of Science.
- The review mentioned that there are communication issues between advising areas, yet it does not seem to be the case, an example was brought forth regarding the Brazilian students and how great the communication has been
- Centralizing administrative tasks may be ok, but specific advising is crucial to the student's success
- General consensus from the faculty of science is to reject the recommendations of the advising review.
- AREAS of ADVISING are: Science Advice, Arts Advice, Student Services, and Program Advisors in some areas

- The Science Advice Centre has Faculty advising which is a huge benefit to the individual departments
- It was noted that the Faculty of Science had voted in the past in favour of a Science Advice Centre with faculty advisors
- Some current advising tasks include: academic warnings, graduation applications, etc. If the advising goes centralized these tasks would need to be handled elsewhere

MOTION: That the Faculty of Science Faculty Council believes that the current advising model is superior to the centralized advising because it allows better access to student science advising and integrates advising between advisors and faculty.
