1. GUESTS and INTRODUCTIONS

Glen Whitfield, Disability Resource Centre (DRC)

- It can take up to 3 months to receive alternate format textbooks, so submit your textbook adoption forms as early as possible.
- There are 3 types of disabilities:
 - 1. Physical disabilities diminishing
 - 2. Mental health seeing a substantial increase
 - 3. Learning disabilities also seeing a substantial increase
- There is a 20% increase each semester in declared mental and learning disabilities.
- We should be aware that not all students with disabilities register with the DRC. Students could decide not to register for a number of reasons and no law states that they have to declare.
- UFV has a progressive approach and is one of the most disability-friendly institutions in BC.
- The DRC has to follow guidelines set by the province to approve accommodations. All accommodations require medical documentation. Instructors should not provide accommodations to a student without going through the DRC.
- The Supreme Court of Canada ruled that all accommodations are reasonable unless it causes "undue hardship" to the institution. There are very few instances of undue hardship. Examples include if it would bankrupt the institution or if the student does not approach the DRC until the day of their exam.
- Privacy laws prevent automatic notification to the DRC or instructors when students register for classes. The privacy laws also prevent the DRC from notifying instructors unless the student asks them to. The same laws prevent the DRC from disclosing details of the student's specific disability or reasons for accommodation.
 - Edward L. asked if the laws would allow the DRC to notify instructors if a student with disabilities registers in their class without disclosing the name. Glen said he will look into this option.
- Small, negative comments such as "maybe you should not take this course" can affect a student for years.

- 5.1 Chemistry Rank and Tenure Criteria
 - The approved standards were distributed in the past and now departments need to create their own standards based on them. Departments should have their standards created and approved as soon as possible because deserving faculty are waiting to receive their new titles. There is no salary increase with the new rank, but it does assist with applying for grants.
 - Country-wide, 5-35% of department members have full professor status. The higher percentages are from research focused institutions. The percentages for new universities is 5-10%, so this is where UFV should fall.
