#### 3. BUSINESS/DISCUSSION ITEMS

#### 3.1. Election of Vice-chair

Duties of the Vice-chair will include representing UEC to the Academic Planning and Priorities Committee and Senate when the chair is not able to attend.

R. McLeod volunteered for the position. There being no further nominations, R. McLeod was acclaimed as Vice-chair.

#### 3.2. Approval process

The Program and Course Approval policy, which is currently under review, includes the terms of reference for UPAC and delegates authority to UPAC and the Graduate Studies Committee (GSC). As UPAC no longer exists and this policy is still being revised, UEC members discussed how best to maintain the approval process in the interim.

Various approaches to the approval process were discussed, including the creation of an interim UEC subcommittee to review proposals and bring recommendations to UEC. There were some concerns about this approach, including the time this would add to the approval process. As some proposals will already need additional approval from APPC and the Budget committee before full approval, UEC was hesitant to further prolong the approval process.

Some members noted that the existing process seems to have worked relatively smoothly in the past, due in large part to the Pre-UPAC consultation that takes place. Former UPAC members noted that their inclusion on the Pre-UPAC e-mail distribution list has helped to keep them informed of up-coming proposals and any potential issues that may arise at UPAC. It was suggested that, if a strong consultation process can be maintained, UEC should be able to fully take over UPAC's business without the use of a subcommittee.

UEC determined that the most efficient and least disruptive course of action would be to fully assume UPAC's role in the current process until the process has been reviewed. A. Grimson will add all UEC members to the current Pre-UPAC mailing list.

MOTION: S. MacMath/E. Spalding

UEC will assume the role of UPAC according to policy 110.29 (Program and Course Approval), until that policy has been revised.

#### 3.3. Meeting times

On the recommendation of the Senate Governance Committee, Senate requested that standing committees consider meeting after 2:30 pm wherever possible. It is often difficult for anyone involved in day-based training programs, such as Trades and Health Sciences, to participate on or attend committee meetings that take place earlier in the day.

After some discussion, UEC members agreed to take over UPAC's regular meeting time for the immediate future (10 am-noon, Fridays Week 4), but to consider alternate times at a later date.

#### 3.4. Policies

Until recently, the Academic Standards Committee (ASC) was responsible for a large portion of Senate policies. Now that this committee no longer exists, Senate standing committees will each be responsible for the review and revision of a number of policies. Nearly 40 of these fall within UEC's mandate, many of which will need to be handled jointly with the Graduate Studies Committee (GSC).

Policy review will be assisted by Lisa Tassone in the University Secretatriat office; she will be asked to provide a list of the policies most urgently in need of review.

#### 3.5. General framework for Honours degrees

The General Framework for UCFV Honours Degrees was approved by UCC on December 11, 2002. However, the requirements included in the minutes do not accurately reflect the material that was presented and approved at that meeting. Specifically, the proposed requirements included "at least one of" four requirements. The minutes however, omit the words "at least one of", effectively changing the requirements to include all four items. B. Cooke requested that the UCC minutes in question be corrected.

MOTION: E. Spalding/S. MacMath

To support a change to the General Framework for Honours Degrees as recorded in the minutes of the December 11, 2002 UCC meeting, to include "at least one of" with respect to the four points included in the second requirement:

- 2. Honours programs must contain additional academic requirements to a corresponding major or degree program as specified by the department that include at least one of:
  - a) Additional credit requirements of up to 12 credits for a maximum of 132 credits for the degree;
  - b) Completion of additional educational activities such as an honours seminar, thesis, or project;
  - c) Completion of new courses specific to the honours degree
  - d) Completion of specified courses already existing in the current degree program but which are not mandatory in that program.

CARRIED RECOMMENDED TO SENATE

#### 3.6. Special admission

Until recently, the Academic Standards Committee (ASC) was also responsible for special admissions cases. ASC delegated the review of some of these cases to Associate Registrar E. Harris, and discussed more complex cases as a committee. As ASC no longer exists and the relevant policy (340.04) is to be revised. UEC discussed how special admissions should be handled in the immediate future.

It was suggested that, in the interim, some members of UEC should be delegated to make decisions on special admissions.

MOTION: W. Burton/R. McLeod

To recommend that, pending the review of policy 340.04, Senate grant authority for decisions on special admissions to a subcommittee consisting of two faculty members of UEC and one advisor, with support from the Associate Registrar, Admissions.

#### 3.7. Cross-listed courses

The B.C. Council on Admissions and Transfer (BCCAT) has expressed concern about UFV's increasing tendency to cross-list courses. There are many valid reasons for cross-listing courses, but it does create some administrative problems with respect to transfer credit. The issue of cross-listing is one that UPAC has discussed several times in the past, but UEC should also discuss it – particularly in light of the impact this has on other institutions.

A. Grimson will compile information on cross-listing, including past UPAC exhibits and minutes, for future discussion.

#### TERMS OF REFERENCE

- 1. Advise Senate on all matters related to the undergraduate educational programs of the university.
- 2. Advise Senate on policies, practices, and criteria for the admission, evaluation, and promotion of undergraduate students.
- 3. Advise Senate on the criteria for awarding certificates, diplomas, and degrees to undergraduate students.
- 4. Advise Senate on the residency requirements for awarding credentials to undergraduate students.
- 5. Advise Senate on policies concerning student withdrawal from courses, programs, or the university.
- 6. Approve the processes for review and approval of new courses, programs, or curricular changes by faculty councils.
- 7. For those curricular matters delegated by Senate for decision by faculty councils, review the reports of the councils and inform Senate.
- 8. For those curricular matters delegated by Senate for decision by the Undergraduate Education Committee, review for approval on behalf of Senate the proposals from the faculty councils and inform Senate.
- 9. Review and consult with the Budget Committee, and advise the Academic Planning & Priorities Committee on proposals for new courses, programs, or curricular changes that require Senate approval.
- 10. Make recommendations to Senate on the resolution of disputes between departments and other academic divisions related to undergraduate course and program development and delivery.
- 11. Consult the Budget Committee of Senate for advice on the budgetary implications of proposals for curricular changes when additional resources are required for implementation of the proposals.
- 12. Periodically review the policies and practices for review and approval of new courses, programs, and curricular changes to ensure consistency and compliance with the goals of the university and with the powers and responsibilities of Senate and the Board.
- 13. Submit to Senate an annual report of the changes in undergraduate education.
- 14. Advise Senate on the annual academic schedule.
- 15. Establish such subcommittees as needed to fulfill the Committee's responsibilities.
- 16. Other duties as assigned by Senate.

**RE:** UCC minutes Re: General Framework for Honours degrees

The General Framework for UCFV Honours Degrees was approved by UCC on December 11, 2002. However, the requirements included in the minutes do not accurately reflect the material that was presented and approved at that meeting. Specifically, the proposed requirements included "at least one of" four requirements. The minutes however, omit the words "at least one of", effectively changing the requirements to include all four items. The audio recording of the meeting verifies that no such changes to the submitted proposal were made by UCC.

At its May 13, 2011 meeting, UECreviewed the evidence andvoted to support a change to the recordto correct this error. UEC proposes the following motion to Senate.

#### **MOTION:**

THAT Senate approve a change to the General Framework for Honours Degrees as recorded in the minutes of the December 11, 2002 UCC meeting, to include "at least one of" with respect to the four points included in the second requirement as outlined below:

- 2. Honours programs must contain additional academic requirements to a corresponding major or degree program as specified by the department **that include at least one of**:
  - a) Additional credit requirements of up to 12 credits for a maximum of 132 credits for the degree;
  - b) Completion of additional educational activities such as an honours seminar, thesis, or project;
  - c) Completion of new courses specific to the honours degree
  - d) Completion of specified courses already existing in the current degree program but which are not mandatory in that program.

UEC recognizes that most honours degrees have been developed according to the incorrect framework, and also, the status of UFV has changed since 2002. The following motion is proposed:

#### **General Framework for UCFV Honours Degree**

Excerpt from minutes of UCC 11 December, 2002

To recognize some of UCFV students who are capable of superior academic performance. An Honours designation would appear on both transcripts and the degree parchment for graduates of such a program.

#### Requirements:

Minimum CGPA of 3.33 (B+) required for admittance to an honours program. Departments may set a higher CGPA requirement.

Honours programs must contain additional academic requirements to a corresponding major or degree as specified by the department:

Additional credit requirements of up to 12 credits for a maximum of 132 credits for the degree

- b) Completion of additional educational activities such as an honours seminar, thesis or project
- c) Completion of new courses specific to the honours degree
- d) Completion of specified courses already existing in the current degree program but which are not mandatory in that program

Students should be aware of the pre-requisites for the above criteria and plan accordingly.

- 3. Students will be admitted to an honours program only if they have completed at least 60 credits, but will not be admitted if they are within 30 credits of completing the degree unless a department has approved a late declaration provision.
- 4. Students who fail to meet the graduation requirements for an honours degree, but do make the requirement for the corresponding non-honours degree program would be awarded the non-honours degree.

#### **Process**

Individual honours degree proposals will be approved by curriculum (or equivalent) committees prior to submission to PAC and UCC. The submission must include an indication of the additional resources required to run the program.

**Discussion:** Wayne highlighted significant changes to the framework as indicated above. UCFV based the CGPA of a high B average from the models at SFU and UBC. The committee did not accept the maximum credit for the degree as outlined in 2a to be beyond 132 credits. The remaining changes were as suggested for minor editing.
