W. Burton indicated that she had serious concerns with the process for course approval. The large number of items coming through Pre-UEC and UEC can be overwhelming, and makes careful consideration of each course impossible.

E. Harris noted that there were potential issues with the Theatre practicum courses as proposed. In particular, other areas should be aware that students may get credit for several practicums, and may want to consider limitations on the number of times these can be applied toward a credential. S. Brigden also suggested that Theatre may want to consider using completely different numbers for the various roles that a student might perform (lighting, set design, etc.). The Theatre department will be notified that there are concerns, and asked to attend a future UEC meeting to address them.

(For example,

students with less experience may be able to provide samples of work but not finished garments.) Three reference letters are generally required.

There was some discussion about the sentence requiring students to submit official transcripts from each institution attended, "whether or not they have completed courses there". The department feels that it can be helpful to see if a student has taken part of a relevant course (drafting, etc.) at another institution; the program does not include a minimum GPA in previously-taken courses, so incomplete courses will not hurt a student's application. The second part of the sentence is redundant however, and can be removed.

There was some discussion regarding UEC's role in approving a program. UEC is not responsible for ranking proposals against one another or considering the budget implications, but rather for checking that a program meets a certain standard and determining whether it is "educationally viable".

W. Burton questioned a statement in the proposal regarding indigenizing the program. V. Dvoracek clarified that there are two separate issues related to this: indigenizing the content of the program, and attracting indigenous learners. This can be clarified in the proposal as it goes forward. S. Brigden suggested that an indigenous angle be highlighted when this is submitted to DQAB.

W. Burton also suggested that the department explore offering all of its courses online, or at least include a statement that students will develop online skills over the course of the program.

UEC members had additional suggestions for courses that Economics may wish to consider including eventually, such as a quantitative research course and CMNS 420 (communicating in virtual teams).

V. Dvoracek will make some minor changes to the proposal prior to Senate.

## 5. OTHER BUSINESS/DISCUSSION ITEMS

### 5.1. Honours framework

There was some confusion at Senate regarding UEC's proposed revisions to the Honours framework, and Senate requested that UEC review and re-submit the recommendations. Some of the confusion may have been due to how the recommendations were presented, so a revised version was included in the UEC agenda package. Additional feedback from faculty and Senate members was also presented to the committee.

One of the concerns raised at Senate was whether an Honours program should necessarily require more time to complete. However, UEC members felt that the discussion should focus on the credits required for an Honours designation, not the length of time, particularly since students have the choice of taking additional courses each semester. The committee agreed that an Honours designation should be an indicator that additional coursework has been completed, and felt that an additional 9-12 credits was appropriate.

UEC recognized the need for flexibility so that departments can design an Honours program that makes sense within their discipline, but also saw the need to maintain a minimum standard across the institution. Some minor changes to the previously-proposed requirements will be made to clarify UEC's intentions.

To recommend that Senate approve the following Honours requirements:

- 1. Minimum CGPA of 3.33 (B+) required for admittance to an honours program. Departments may set a higher CGPA requirement.
- 2. Honours programs must contain additional academic requirements to a corresponding major as specified by the department. These requirements will consist of completion of an additional 9 to 12 credits that include completion of upper-level educational activities such as an honours course, seminar, thesis, or project. Students should be aware of the pre-requisites for the above criteria and plan accordingly.

3. Students who fail to meet the graduation requirements for an honours degree, but do make the requirement for the corresponding non-honours degree program, would be awarded the non-honours degree.

## 5.2. UEC Terms of Reference and membership composition

### Terms of Reference

There were some concerns that the Terms of Reference as proposed are too broad and create a committee that is unwieldy, particularly since UEC has not been able to get through the entire agenda for the last two meetings. Part of the problem seems to be that UEC has had to take on some of ASC's role in addition to that of UPAC.

Overall, UEC members felt that although it may not be feasible to carry out all of the duties in the proposed Terms of Reference, they should be accepted for the time being. It may be necessary to make additional changes in the future, but this will allow the committee to move forward. It was noted that the alternative is to continue to operate under the existing Terms of Reference, which are even more unwieldy.
