5. NEW/CONTINUING BUSINESS

(a) Title and Course Description Changes to ENGL 120

Rhonda Schuller reviewed the title and course description changes to ENGL 120. These changes came

out of recommendations in the Program Review two years ago. English 110 was dropped. The new title for ENGL 120 will be "Introduction to Modern Fiction". This keeps the description and period of literature covered in-line with other first-year courses. The change also allows ENGL 120 to pick up coverage of shorter fiction, lost with the deletion of ENGL 110.

Rhonda was asked to clarify the issue of whether PLAR can be obtained for this course and send a revised document back to PAC for information. Rhonda noted that transfer credit will be requested but it does not appear in the BCCAT Transfer Guide at the present time.

ENGL 120: 3 credits

Introduction to Longer Modern Fiction

A study of some of the main themes and techniques in the modern novella, and novel, and short story. Students are encouraged to read these literary forms attentively and discuss them articulately.

New Courses: ENGL 333 & ENGL 335

Rhonda Schuller noted that ENGL 333 was intended to amalgamate the former ENGL 332 and ENGL 334 into one course allowing students to have full coverage of authors of the Victorian period in one semester. This also would allow a course that could be offered more frequently, rather than on rotation of two courses.

It was suggested that a note appear in the calendar indicating that ENGL 333 was formerly ENGL 332 and ENGL 334. It was suggested that on the course outline under Synonymous Courses (a) Replaces: it should read: ENGL 332 or ENGL 334.

It was noted that the two courses combined into one may have credit implications for students since two courses, with a total of 8 credits, was combined into one course with 4 credits. Rhonda was asked to look at these implications for students and send a report to PAC.

ENGL 333:

Nineteenth-Century British Novelists

4 credits

(formerly ENGL 332 and ENGL 334)

Prerequisite(s): Any two second-year English courses.

This course will explore novels written by such major authors as Austen, Scott, Gaskell, Thackeray, Dickens, Trollope, the Brontës, George, Eliot, Hardy, Gissing, and George Moore.

ENGL 335:

Topics in Victorian Literature

4 credits

Prerequisite(s): Any two second-year English courses.

Topics in Victorian literature will be drawn from the rich offerings in Victor and art.	ian poetry, fiction, nonfiction,
ENGL 332	4 credits
ENGL 334 ENGL 336	4 credits 4 credits

(b) New Course: BIO 325

Terry Starr noted that BIO 325 was a new course that would allow Biology major students to complete their requirements at UCFV rather than having to go to SFU or OLA.

BIO 325:

Introductory Medical Microbiology Prerequisite(s): BIO 201, BIO 203

Corequisite(s): BIO 202

4 credits

The course focuses on the relationship between human health and microbes. The functioning of the immune system, the normal human flora, and diseases caused by microbial pathogens will be studied.

Prerequisite Change to BIO 203

Terry Starr noted that the requested addition of CHEM 101 and CHEM 102 with a "B" or better prerequisite change for BIO 203 was to make in consistent with Chemistry department standards. Terry was asked to work with Varlene MacLeod and Elaine Harris on making the prerequisites clear for calendar copy. Terry noted that the course is running now and will not be offered again for at least another year.

Microbiology I (3,0,3)

4 credits

Prerequisite(s): BIO 112, or (BIO 101 and 102 with a "B" or higher); and CHEM 112 or (CHEM 101 and CHEM 102 with a "B" or better).

(c) Mathematics Major (BSc) and (BA) Proposal

Greg Schlitt noted that there were four proposals sent to the DPRC, a Major in Mathematics, B.Sc., Major in Mathematics (Stats Option), Major in Mathematics, B.A., and Major in Mathematics (Stats Option). The Major in Mathematics (Stats Option) B.Sc., B.A. was dropped at the DPRC level. The program proposals presented to PAC were V. Sc. Major in Mathematics and a B.A. Major in Mathematics. Currently, a Math minor in science is offered as part of a double minor (minor in Math and a minor in biology) for the B. Sc. Degree. As well, in the Arts as both a minor and extended minor for a BA. These degrees have limited attraction for students. One of the problems with the minor degrees is that a large number of prerequisites required, especially in Math and science. The Major proposal is built on the back of these minors and the only change is that there is a requirement for 30 upper-level credits. It is proposed that the department continue to offer the upper-level courses at the same rate with no additional cost to the institution. Research has show there is student demand and the job prospects for students are very good.

It was requested that the letter from the DPRC approving the proposals be presented to PAC for

information.

It was suggested that the Stats Option be removed from the proposal presented to UCC since it was removed from the DPRC presentation.

Enrollments for classes were discussed. Greg stated that the average enrollment in Math this year is approximately 29-30. They expect enrollments in upper-level courses to increase with offering of the major.

Greg noted that at the rate the department is able to offer upper-level courses it is possible that it will take students up to six years to complete this degree. One of the requirements the DPRC but on their approval confirmation from SFU that students who wish to transfer to SFU in order to complete their degree, in a shorter period of time, will be able to do so and that this be made clear in the calendar. Greg was asked to indicted where this would go in the calendar and to send a copy to PAC for information.

(d) Physics Major (BSc) Proposal

George McGuire noted that the Physics Major (B.Sc) had been approved by the DPRC. Industry and representatives from other institutions, in an external review last year, recommended that there be a Physics degree offered at UCFV. There is a demand and enrollments are expected to grow because of this degree. Lower-level classes average 27 students – upper-level classes average 11-12 and growth is expected because of the degree. George noted that he wanted to acknowledge the excellent advice and help received from SFU (Dr. Bob Frindt and Dr. Al Curson, and Dr. Dave Wall). Also, thanks to UBC for their advice and cooperation as well.

George noted that this would be an excellent laddering degree to a number of high tech fields and jobs in medicine, chemistry, computers, engineering, etc.

On page 7 George was asked to insert "COMP 100" in the last line of list of general requirements.

It was suggested that because of the introduction of majors there needs to be a review of the calendar for the Bachelor of Science to see how the general requirements and the majors fit with it. Physics, Chemistry, Math and Biology were asked to work with Varlene MacLeod, Bill Cooke or Elaine Harris to figure out calendar copy that makes sense to students. A copy of this should come back to PAC for information.

In answer to a question, George noted that students will be able to complete their degree at UCFV but it will take longer than four years. The department hopes to be able to combine with Co-op semester so they can pick up courses specifically needed. Students can also complete at SFU under a general students plan but get priority registration. There is a lot of flexibility for students.

(f) New Course: CHEM 241

Noham Weinberg noted that the department had been requested by DPRC to have this course included in the Chemistry Major proposal. All the resources are in place to present CHEM 241.

CHEM 241:

Analytical Chemistry

4 credits

Prerequisites: CHEM 111 and CHEM 112, or CHEM 101 and CHEM 101 with B+ or higher.

Corequisites: None

An introduction to analytical chemistry with an emphasis on analysis of solutions. Lecture material includes data and sample handling, principles of titrimetry and electrochemical methods, as well as an introduction to chromatography. Laboratory experiments illustrate lecture material.

(g) Changes to Sociology Major Program

Jean Ballard noted that the department had been struggling for the past five years to find a way to maintain the integrity and profile of all four disciplines (Anthropology, Sociology, Latin American Studies and MACS) and still operate on a limited budget in a ways that serves the needs of students. In the past few years it has become apparent that students have been having difficulty completing their extended minors and majors in a four year period. A number of ways of overcoming this problem were investigated and department heads met with the heads of Sociology and Anthropology and Media Communications at UBC, SFU, UVic to try and develop ways of making the department's offerings more efficient.

Jean reviewed the suggested changes which were:

- 1. <u>Changes to Sociology Major</u> Change name from "Sociology Major" to "Sociology/Anthropology Major" which more accurately reflects the content of the major.
- 2. A MACS Minor will be added. Letter of Intent going to UCC in October.
- 3. <u>Sociology Extended Minor Discontinued</u> By eliminating this option focus will be put on the major and minors and have room to develop a winder range of course offerings for students.
- 4. Anthropology Extended Minor Discontinued (same rational as above).
- 5. LAS Minor Revised Spanish requirement removed making the LAS minor more accessible to more

students.

- LAS Extended Minor Revised recognizing second-year Spanish courses now available at UCFV.
- Rename Cross-listed Courses to SCMS to reflect their multi-disciplinary nature.

Jean Ballard stated that a phase out will begin by September 2000. Students will be asked to declare their BA by April 2000. Those students who can't declare will be advised on a one-on-one basis. High School counselors will be advised on a regular basis. No new courses are needed for the major.

(j) Other PAC Business

A discussion was held regarding class sizes and resources. It was noted that there was a web site that notes all class sized. It was also noted that class size was not part of PAC terms of reference. PAC has to decide that something is worth doing, then it is up to the department and the Dean to find the resources.

Another issue that Norah Andrew agreed to take to Senior Management was how all the degrees fit together and whether or not approval of degrees in isolation is what the institution wants to see happen.

The issue of how often a course is offered is important to help students plan their courses. Often departments will put a sentence in the calendar informing when the course will be offered. The planned frequency of course offerings is on the new course outline, however, there needs to be flexibility. It is important to have available for students course cycling plans by a department.

The approval process for mounting a new degree was reviewed.
