# New Course – MATH 488: Selected Topics in Statistics

Barry Garner noted that MATH 488 is designed for students towards the end of their degree. This course will allow the Math faculty the opportunity to teach a topic that falls outside of the usual Math course offerings. This will also allow the department to recruit an instructor from another institution to teach in his/her specialization in the field of statistics. The topics covered will be limited to those, which UCFV's Library resources can support. Implementation Date: September 2002.

PAC decided that, "May not be repeated for additional credit" should be added to the Calendar description. The Math Department will therefore update the Calendar Description section in the Course Outline, and resubmit it as an Information Item for the next PAC meeting.

#### **MATH 488:**

# **Selected Topics in Statistics**

3 credits

Prerequisites: Four upper-level Mathematics courses, including at least three listed under the statistics option for the BA or BSc degree. Certain programs of study may require more particular prerequisites. The written permission of the instructor is required.

This course is designed for students who wish to examine in greater depth a particular statistical technique or application. It will be offered either as an individual reading course or as a seminar, depending upon student and faculty interest. May not be repeated for additional credit.

#### 4.0 INFORMATION ITEMS

# 4.1 <u>Course Outlines – CYC 350 & CYC 351</u>

# CYC 350: Law and Social Services

Bill Cooke Chaired this portion of the meeting.

As requested at the last PAC meeting, D'Anne Epp had submitted the Course Outlines for CYC 350 and 351.

A discussion was held on the Student Evaluation uneven distribution of marks. The Committee could not understand why 50% of the course mark was assigned for the midterm exam. D'Anne explained that CYC was being consistent with the SSSW Department, by having the same marking scheme for the CYC 350 as SSSW 312 had. It was noted that the marks for CYC 351 were more evenly distributed. PAC was unaware of how many other UCFV courses have the same or similar marking distribution. There was also uncertainty whether UCFV has any quidelines regarding the distribution of course marks.

That PAC approve the Course Outlines for CYC 350 and CYC 351, with the deletion of the number "1" in the prerequisites.

Dave Burnie abstained because of the uneven distribution of course marks. He would like an SSSW representative to attend a PAC meeting and explain the rationale for having such a high portion of marks (50%) assigned to one exam, the midterm exams.

D'Anne Epp was requested to invite Gloria Wolfson from the SSSW to attend a PAC meeting to

- Why is the midterm exam worth 50% of the course mark?
- Is the 50% midterm mark correct, or is it an error?
- Is the course a government exam therefore it is allocated 50% of the marks?

#### CYC 351: Legal Skills for Social Service Professionals

A discussion was held on the Course Outline for CYC 351. Under Synonymous Courses, "N/A" should be replaced with "350B". The Transfer Credit should indicate "no". D'Anne Epp noted that there were enrolment difference because CYC allows more students in the department than SSSW does. SSSW typically does not take in over 24 students. Although CYC can take in over 24 students, the department has never gone over 15. Bill and Virginia Cooke wondered if there was legislation to regulate class size and thought that this issue should be examined.

# • ECE 269: Foundations of Infant Caregiving

D'Anne Epp noted that the prerequisites for ECE 269 had been tightened up. A discussion was held on ECE 269. This is a theory course. PAC noted that it would have been very helpful if D'Anne had also brought the corresponding practicum to this course in order to fully discuss both the theory and practicum aspects of the courses. D'Anne pointed out that students must take the foundation courses before the practicum. Since the UCFV calendar will only be printed every two years, with the next copy being produced in 2004, it was felt that in order to inform students about this course, that it should be implemented for the Fall of 2002. It was decided that the prerequisite should also include "or permission of department head". D'Anne will provide PAC with the associated practicum at the next PAC meeting.

### • ECE 213: Atypical Development

D'Anne Epp explained that the prerequisites and Calendar Description for ECE 213 had been revised. The course number change from 413 to 213 had already been approved by PAC last year. Students do not have to be in the diploma program in order to take this course. Bill Cooke explained that ECE 213 was not an upper level course.

**Atypical Development** 

3 credits

Pre or Corequisite: Certificate in ECE or enrolled in Introduction to Health and Human Services Career Certificate.

An Introduction to the understanding of specific disabilities and how a child's development can be affected in the home and school environments.

Virginia Cooke opposed the Motion to approve ECE 213. She objected on the grounds that, it was inappropriate to bring ECE courses for discussion to PAC without prior notice when, at the Chair's direction, she had recently turned down a request. Neil Campbell had approached PAC at the last minute to include prerequisites to ESL courses – prerequisites which had previously been approved by PAC in the past, but had been omitted from the Calendar. Neil also needed to bring some of the Course Outlines up-to-date. To make up for the prerequisite omission, Virginia had therefore asked the Calendar staff to insert before the course entries, "Note: All ESL courses have prerequisites or corequisites. For detailed and accurate information on prerequisites, a list is available in the ESL Office or from the department head."

A discussion was held and a compromise was reached.

That PAC gives approval for the ESL portion of the Calendar which notes that the ESL courses have prerequisites and that students must check with the ESL Office or department head for accurate information, as discussed.
