#### 3. UPAC BUSINESS

## 3.1. Latin American Studies

## 3.2. Social Work and Human Services

Change to courses: Renumbering of 400-level HSER courses to 500-level

These courses were historically offered at the 600 level, but the department was asked to make them 400-level courses when UCFV developed graduate studies. The department subsequently asked to

change them to the 500 level, and this was approved by UPAC on March 3, 2006. However, the changes were put on hold at UCC on March 17, 2006, pending final approval of policy 210.14. The policy was approved by UCC on May 26, 2006, defining 500-level courses as "Post-baccalaureate courses that require a baccalaureate degree or equivalent preparation to study at a higher, but not graduate, level and may be used as professional development to maintain a credential or professional status." UPAC was to reconsider these courses for appropriateness at this level. The courses in question are not for entry-level students, but are offered at a professional level.

## 3.3. Competitive entry rating scales in calendar

H. MacDonald presented some concerns that Health Sciences has over the implications of the decision made at the February 2, 2007 UPAC meeting to include links to rating scales in the calendar. Although Health Sciences supports transparency, they are concerned that giving the full, detailed rating scale will generate a high level of inquiry that they simply cannot handle. As this is a new process, Health Sciences would prefer to begin by making a summary of the criteria available rather than a detailed breakdown.

UPAC's original intention was to make students fully aware of all competitive criteria. As long as the summary includes all criteria on the rating scale, this should be sufficient.

To reconsider the motion from the February 2 UPAC meeting, and amend it to the following: To include links to rating scales *or a summary of the rating scales* in the online calendar for every program that uses a rating scale for admission.

**CARRIED** 

One of the concerns at the February 2 meeting was that the Dental Hygiene rating scale contained items which were not included in the entrance requirements. These are not required items, but are areas in which candidates can receive extra points. S. Stegmueller's concern was that students may not be aware of all criteria that they may be evaluated on.

B. Cooke suggested that UPAC may want to require the inclusion of all competitive entry criteria in the entrance requirements. However, E. Dennis questioned whether these actually belong in the entrance requirements; although additional criteria could be considerations for admission, they are not requirements. Students should certainly be aware of all possible criteria for competitive admission, but the entrance requirements may not be the most appropriate place for these. The new "basis for admission decision" section will be based primarily on the entrance requirements, but should also include any additional factors.

The basis of admission section should include the entrance requirements and any additional criteria that may be considered. This must be clearly stated.

## 3.4. Cross-listing of courses

B. Cooke presented a new version of the cross-listing proposal, which has been distributed to department heads for comment.

The current document indicates that each course will be owned by either a department or a discipline-focused curriculum committee. Questions were raised regarding how a curriculum committee is initially formed. E. Davis indicated that the dean ultimately approves the size, nature, and make-up of a curriculum committee. It was suggested that this statement be changed to read as follows: "If there is no department, then a committee focused on the discipline and recognized by UPAC will act as the owner of the course."

L. Howe suggested that we may need a course labeling policy to make ownership of certain course codes clear, as incorrect labeling of a course my cause the institution to lose credibility with various stakeholders. S. Brigden mentioned that examples of such a policy may exist at other institutions.

W. Burton sent a comment that approval of the originating department should be obtained in order to create a cross-listing. R. Welch sent suggestions for wording regarding discontinuation of a cross-listing: "If a cross-listing is to be discontinued, the department must advise the department offering the course, the relevant curriculum committee, and UPAC of their intention, including why the cross-listing is being discontinued." B. Cooke will incorporate some of these suggestions, and prepare another draft.

Definitions should also be defined and included in this policy. S. Brigden will look for examples of similar definitions at other institutions.
