#### 1. APPROVAL OF UPAC AGENDA

#### 2. APPROVAL OF UPAC MINUTES

**2.1.** UPAC Draft Minutes: May 25, 2007

The manner in which information items are included on the agenda was discussed. As the information items often include a large number of course approvals, it was decided that a new agenda section be created specifically for approved course outlines.

#### 3. UPAC BUSINESS

**3.1.** Framework courses in support of student exchanges

B. Cooke noted that the distributed course outline was a draft framework course, and approval was not being sought. This was brought to UPAC for advice on how best to approach the issue of student exchanges at other institutions. These students pay UCFV fees, and are given transfer credit for their completed coursework. Exchange courses have been done in the past through International Education, but are now more formalized. A&R would like to have these students registered in an "exchange" course for transcript purposes, so that transcripts not only reflect the credits earned but also show that an exchange has taken place.

The proposed course has no credits attached to it, but this creates problems with Financial Aid applications; Financial Aid would prefer that this be a credit course. Other institutions approach this situation in a variety of ways. Some set up the exchange as a credit course and later change it to zero credits when the exchange is complete, while others give credits for the exchange but no credits for actual courses completed, although these still appear on the transcript.

R. Kelley mentioned that there could be problems for students if the course appears on the transcript with "zero credits" awarded, and asked if there would be another way to communicate this information. B. Cooke indicated that the "credits" cannot simply be blank; a number must be given. Sample transcripts may be helpful in determining how best to convey this information.

UPAC members discussed whether it was necessary to indicate an exchange on the transcript, but saw no reason not to. There could be a course associated with every exchange agreement.

B. Cooke will revise the course outline and determine how best to proceed.

#### **3.2.** Final course outline review

Minor changes to the official course outline form were suggested. In the PLAR section, "Examination" and "Interview" will be changed to "Examination(s)" and "Interview(s)". The Methods section will include examples of possible methods of delivery.
