HIST 241 and 264

- Recommended Evaluation Methods and Weighting: The memos speak to EDI and the variety of assessment methods that are used in these courses. CACC suggests that History revisit this section of their outlines to see how the assessment method spoken to in the memos could be more strongly reflected in these outlines.
 - o For instance, the weighting for exams, tests, and guizzes is guite

heavy, but after speaking with History, it seems that some of these items may be able to be shifted to Assignments with examples of the types of assignments listed.

 Evaluation Methods and Weighting: The memo generally speaks to the use of inclusive and flexible assignments. CACC suggests adding more specific details or example of assignments.

PHIL 483

 Calendar Description: PHIL confirmed that students should be able to take this course more than once, and that letters will be used to represent different versions. CACC recommend a note is added to the outline to reflect that student can receive credit for the course more than once under different letters.

Learning Outcomes: CACC noted that the Learning Outcomes for these
courses use lower taxonomy verbs. They suggest that PHIL review these
LO to see what higher-level verbs could be used instead to better reflect
that level of learning that the upper-level students will be assessed at.

- CACC recommends double checking prerequisites for courses that have been discontinued for more than five years and suggest removing them from the prerequisites.
 - o For example, ENGL 280 could be changed to *any two 100-level English courses numbered 105 or higher.*
- Course Topics: A reminder that Course Topics should be presented in a bulleted list without specific weeks noted.

ENGL 280

• Memo: Small typo on p. 145 (T The)

ENGL 388

 Learning Outcomes: CACC encourages ENGL to consider using higher level taxonomy verbs, which will better describe the level of assessment that is happening at the 300 level. Verbs such as identify and describe are considered lower-level verbs
