- Revise bullet 6 of the Entrance Requirements to "current list of..."
- Revise the second paragraph of the Documents Required section to "official transcripts must be sent..."
- Recommend adding a reference to UFV policies under the sixth Entrance Requirement.

## 3.1. SOWK 300 Social Work Practice with Individuals – Major Revisions – Brianna Strumm

## **MOTION:**

- In the memo under #6, revise to "anti-oppressive".
- Under Recommended Evaluation Methods, two categories are called "Assignments". One should be renamed for clarity. More details on how participation is evaluated is recommended.
- Correct the numbering under Course Contents and Topics.
- Do not remove "Interviewing and assessment" from Course Content #7.

• Recommend revising the Recommended Evaluation Methods section so the details more clearly match the percentage breakdowns.

### 3.3. Early Childhood Education Certificate – Major Revisions – Gena Hamilton

### **MOTION:**

That the major revisions to the Early Childhood Education Certificate be accepted and recommended to ECHD Faculty Council with the following amendments:

- Add a rationale in the memo for removing the orientation requirement.
- In the calendar copy, remove mention of the specific campuses.
- In the calendar copy's third paragraph, add a sentence saying why
  criminal record checks are required. One suggestion was "under the
  Criminal Records Review Act, students in a professional postsecondary program with a practicum component involving work with
  children and/or vulnerable adults must undergo a criminal record
  check."
- Under Entrance Requirement #2, add "see program preparation section below".
- Remove the added practicum note box under Entrance Requirement
- Under Dates and Location, revise to "offered over four semesters" in order to remove mention of the specific campuses.
- Recommend adding a sentence to bullet #3 of the Additional Documents section referring applicants to the website.
