2. AGENDA and MINUTES

2.1 Adoption of Agenda

3. **DEAN'S REPORT** – Lucy Lee

3.1 <u>Fraser Valley Regional Science Fair</u> – School District #34 has been the main coordinator of the FVRSF with UFV assisting for several years. After discussions between the other School Districts involved they have requested that someone neutral oversee the FVRSF going forward. UFV was approached. Lucy has taken on the role of Chairperson. She advised that volunteers will be needed for the Science Fair scheduled for April 4-7, 2017. More details to follow.

- 3.2 <u>SFC Format for 2017</u> Lucy suggested adding a new item to our SFC meetings starting January 2017 to showcase research going on in our faculty. At the beginning of each meeting a faculty member or one of their students can present for 15 minutes and follow with a 15 minute Q&A. Lucy agreed to begin on January 6, 2017 and bring in one of her students to present. Please let Lucy know if you are interested in presenting at further SFC meetings. (After the meeting David Harper offered to present on January 6, 2017).
- 3.3 <u>Indigenizing the Academy</u> Joslynn Lee from the Cold Springs Harbor Lab in New York presented on November 30th as part of the Science Dean's Seminar Series.
- 3.4 <u>Get to know our campus</u> Lucy would like to organize a walking tour similar to the "Place Name Tour". Allan Reid has volunteered to give a walk-about tour of the UFV Campus which will provide fitness and knowledge of our environment.

A discussion followed regarding the dual-listed 400 courses not being included on the course outlines. A minor revision was recommended to add the dual-listed 400 level courses to the 700 level outlines. A further discussion followed with concerns on the 700 level learning outcomes. They are very similar if not exact to the 400 level courses. It was decided that Allan Arndt shall prepare a cover letter memo to accompany the course outlines to ensure that the explanation is clear when it goes to GSC.

5. **DISCUSSION / DECISION**

5.1 Ketones Study – David Harper

David H. provided information on a Ketones Study that he and his students will be taking part in at UFV. He was approached by Pruvit, a company in Texas regarding a ketone trial. Pruvit has also been working closely with other universities and research facilities including the US military. Ketones have been known to improve focus and concentration. He asked faculty to contact him if they were interested in their class participating. He will be sending out a formal request later and have Kinesiology students come out and speak to classes about the study which should take place in the fall 2017.
