## 3. ENGINEERING PHYSICS DIPLOMA PACKAGE

3.1. Engineering Physics Diploma – New Diploma

Brief overview of the program was given. This could be a step towards other programs such as a degree.

Suggestions from FSCC (Curriculum Committee); see attached documents:

- UFV Institutional Research Survey might be beneficial
- Re: International reserves there is no cost difference if the current ratio was changed
- Typo in document: \$7500 cost reference should say 'per term' not 'per course'
- Comment: 24 students versus 18 students 18 is a break even number and increasing to 24 would definitely be more manageable. No decision has been made regarding any changes to the International/Domestic ratio.

#### 4. AGRICULTURE CENTRE OF EXCELLENCE

Documents were circulated and are also available on the Public Drive: H.

John English gave an overview of the 'vision' of the new centre.

- Initial resources and criteria have not yet come forth to start the program.
- Committee is accepting vision ideas from all the Faculties
- Faculty of Science is adding two diplomas; Agriculture Diploma, & Engineering Physics
   Diploma
- Ideas include: Automation Technician, Agribusiness, and tourism which organizations to see what would be relevant to jobs within the Fraser Valley?
- Some things that are not on the list: Energy, land use, secondary food processing
- The process is in the beginning stages and communication with the Faculties has begun.
- Science and business may be key areas of interest.
- Looking for ideas on what would be the principles that would guide the committee's selection for the Centre of Excellence.
- Question to ask is what the government and the industry expecting.

- 7. DISCUSSION and DECISION
  - 7.1. Scholarship, Service and Teaching

The committee has completed this first task by creating a grid that will be ready for circulation for the next Faculty Council meeting.

A new committee is needed for the next step to discuss in further detail regarding the specific ranks.

NOTE: Dec. 31<sup>st</sup> is the deadline for all applications.

It is understood that there will be two separate processes, one for current Faculty and one for new hires starting in January 2014.

There will be grandfathering for those not on probation. There seems to be some confusion regarding the meaning of the grandfathering clause and also for those on probation.

ACTION: DEAN'S OFFICE: Regarding Rank and Tenure document submission deadline of Dec. 31st - Send clarification to all Faculty as to what the process is and what is expected from them. Could FSA be invited to the next Faculty Council meeting? Is there any movement on "lab Instructor" language? Please clarify what type of additional document is required for submission (dossier or teaching philosophy).

ACTION: Departments: Elect or nominate one member to be a part of the new Scholarship, Service and Teaching committee (previous committee has completed initial task). The purpose of the committee would be to bring more clarification regarding the ranks (including lab instructors, instructors on probation, etc.). The committee would take back to the department for discussion and then back to Faculty Council.

#### 7.2. Open Textbooks

- These books are open source books which can be used by everyone. It is recommended that Faculty have a look at the books that are listed and make comments.
- A large selection open source books is currently available from the UFV Library.
- The concern from the Teaching and Learning Council is that the government may want to have these books regarded as mandatory use.
- These books don't seem to be very sufficient and would be a concern if they were to become mandatory.

- Why are these particular books being brought forth from the BC Government?
- Is the BC government trying to promote a list of synonymous courses for transfer credit?
- Could this be a way to provide more resources for students?
- There is the issue of the cost of textbooks for students and also the general cost of education itself.
- Examples were given regarding some ways that instructors could give students more economical choices for books

#### 7.3. Review of Policy 101 – Grading System

- The changes at the lower end of the scale seem to make sense since the UFV
   Continuance policy states that "Students must have a CGPA of at least 2.00 to remain
   enrolled in Good Academic Standing at UFV."
- Discussion regarding the grading system and the fact that Geography and Science tend to be severely disadvantaged when it comes to scholarships. There should be equal access to scholarships.
- A summary of grades could be a useful report to receive from Institutional Research.
- The wording of grading tends to be a different interpretation across the disciplines.
