Office of Research Services RAC Report | November 14, 2024

- The Faculty Student Research and Scholarly Activity Fund deadline was September 16, 2024. Adjudication took place in September and applicants were informed in October as to whether or not they were successful. Total applications received were 17 and a total of 7 applications were funded.
- ROSA applications were due on October 31 with a one week extension provided to those who were submitting external grants on November 1 (NSERC Discovery and SSHRC Connection Grants). Orientation to committee members who will be adjudicating these grants is happening in November. The committees will be provided with the applications by the end of November. The committee meetings will take place in January 2025 with applicants being notified early February 2025.
- One International Development Research Centre (IDRC) grant was submitted in September 2024 and was funded. The lead applicant is located in Ghana and the UFV co-lead is located in the Centre for Justice, Equity and Sustainable Action (JESA).
- Two Michael Smith Health Research (MSHR) Convening & Collaborating grants were funded from UFV. The applications were submitted in May 2024. The applicants were from the Faculty of Health Sciences and Nursing. They were funded a maximum of \$20,000 each.
- One CIHR Early Career Researcher Workshop was awarded to an applicant in Biology. The workshop will be held in Toronto at the end of November and covers the applicants' costs associated with travel, accommodation and poster printing for the workshop.
- One NSERC Alliance Catalyst Grant was submitted in August and was successfully funded. The applicant was from the Planning, Geography and Environmental Studies department and they were funded at a maximum of \$25,000.
- 13 NSERC Discovery Grants were submitted on November 1. Funding decisions should be out in March/April 2024.
- 2 SSHRC Connection Grants were submitted on November 1. Funding decision should be out in January 2025 as the next intake to apply for this grant is February 1 as it is a quarterly grant with 4 application dates per year.

- One CFI John Edwards Leaf Foundation (JELF) Grant was submitted in February 2024 and the follow up application was submitted to the BC Knowledge Development Fund in March 2024. The applicant from the Luminescence Dating Laboratory was successfully funded for \$63,238 from each funder for a total of \$158,095.
- One Targeted Geosciences Initiative Grant (TGI) was submitted in September. The applicant should be notified of the results in the next coming months.
- Four SSHRC Insight Grants were submitted in October. Applicants should be notified in March/April 2025.
- Two BC Parks grants by the same applicant for different projects were submitted in October. The applicant should be informed in the next few months regarding the results.
- One NSERC Research Tools and Instruments Grant was submitted in October 2024. The applicant should be informed in March/April 2025.
- One Canadian Space Agency (CSA) grant was submitted in October. The applicant should be informed in the next few months.
- One SSHRC Partnership Grant-Stage 2 (invited) was submitted in October. The University of Victoria was the lead applicant. The co-applicant is from the English department.
- One SSHRC Partnership Development Grant will be submitted mid-November. The lead applicant is from Toronto Metropolitan University. The co-applicant is from the Graphic and Digital Design department at UFV. The applicant should be informed in March/April 2025.
- Two NSERC Lab to Market grants (full applications by invitation) were submitted in September. Both applications are being led by other institutions, but the UFV co-applicants are located in EFCIE and FAI. Applicants should be informed in the next few months.
- One NSERC Promoscience Grant was submitted in September. The applicant was from Mathematics and Statistics and was applying on behalf of the Faculty of Science for outreach activities relating to STEM which are already in place at UFV. Results should be released March/April 2025.
- **Reminder:** The Government of Canada has come out with a policy relating to Sensitive Technology and Research Affiliations of Concern (STRAC) in order for researchers and university administrators to understand best practices to identify and mitigate research security threats, pursue and maintain safe research partnerships, maintain institutional reputation of a safe research organization and protect valuable research, data or potentially patentable property. - **Reminder:** Mitacs programs are a great way to work with an external partner and also provide your students with valuable training skills. Mitacs programs do require a 50% match from an external partner which they will then match. A list of possible projects/partners will be advertised in the next research newsletter. More information about Mitacs programs can be found here: <https://www.mitacs.ca/discover-students/>
- **Reminder:** Mitacs also has an Indigenous Pathways Stream which allows for a smaller contribution of 25% from the partner for applications that have an Indigenous partner organization and/or an intern who is Indigenous. Further information can be found here: <https://www.mitacs.ca/about/indigenous-pathways/>
- **Reminder:** All research grants and contracts must go through our office for a review regardless of who completes the submission to the agency. Please ensure that you are noting the appropriate overhead/indirect costs on the overhead waiver form which can be found online. As per university policy, our overhead rate is 25% unless the funder waives the rate or has a reduction of that rate noted on their website or in their instructions. For most (but not all) Tri-Agency grants there is no overhead. If you have any questions, please contact Ash Lalani.
- **Reminder:** If any faculty members are working on any grants/contract (Tri-Agency or other funding organizations) please contact the Director, Research Services and Industry Engagement, Ash Lalani ash.lalani@ufv.ca ASAP to help review your application and provide guidance on next steps, review, submission process etc. We have an internal process for **at least 14 business days prior to the deadline date**. This also includes those working as co-applicants with other institutions that may require a letter of support.
- **Reminder:** The Research Office and Library at UFV are currently working on some consolidated information to help researchers with their research data management plans (RDM plans). **Currently there are only selected programs that require a RDM plan that would need to be completed prior to submission. - **Reminder:** major grant holders may be eligible to receive one teaching release if they are the Primary Investigator (PI) for **a major grant from only select NSERC, SSHRC, and CIHR grants**. Please see specifically point #1 on our major grant holders website for the changes. Co-principal investigators and co-applicants are not eligible due to lack of funds our office has at this time. This information is noted on our website.

- **Reminder:** regarding major grant holder releases, the releases are eligible for the duration of the grant (# of years total) but they are not applicable to extension years taken after the term of the grant. For example: You hold a Tri-Agency grant as the principal investigator for three years total, you are eligible to apply for a release for each year. If you decide that you will opt for the extension (providing the grant allows for it) then you would not be eligible for a release in the extension year. This information is noted on our website.
- **Reminder:** If are going to be working on a NSERC Alliance grant, please ensure that you check in with the Director, Research Services & Industry Engagement to discuss if there are any partnership/security risk concerns. NSERC Alliance grants have a rolling deadline unless specified as a special call with a hard deadline.
- **Reminder:** The next SSHRC Connection grant competition will be held on February 1, 2024 as this is a grant that has 4 application intakes per year (February, May, August and November).
- **Reminder:** The next SSHRC Partnership Engage grant competition will be held on December 15 and this is a grant that has 4 application intakes per year (March, May, September and December).

TLAC Report – November 2024

1. TLC and UFV International are jointly supporting COIL: Collaborative Online International Learning. See Flyer attached.
2. The [UFV AI Principles](#) have been approved by Senate: “These UFV-wide AI Principles provide a framework for all university sectors and divisional areas to develop their own specific guidelines. The AI Principles help UFV be both consistent and flexible in its response to AI in a manner that is aligned with other post-secondary institutions.”
3. D2L Brightspace has been announced as UFV’s new Learning Management System. Approximately 15 faculty members are piloting the LMS in Winter 2025, and it will be rolled out during the summer to all courses for implementation in Fall 2025. Collaborative Online International Learning

A COIL project involves two or more faculty members from different universities that collaboratively develop project to be completed by students in both their classes. Students work together virtually to explore driving questions related to the course material and gain valuable teamwork skills and interdisciplinary and intercultural perspectives on the issues facing our world.

UFV will run a COIL training program to support 10 faculty members to redesign a course, across any discipline to incorporate a collaborative, virtual global learning experience. With a faculty member from a partner institution, they will participate in 5 workshops between January and March 2025. Afterwards, each faculty pair will implement two COIL courses together within two years. The training program is led and fully funded by UFV and will be implemented by Going Global U, led by Greg Tuke and Karim Ashour, who together have taught more than 30 COIL courses and trained over 200 faculty members in more than 20 countries.
