That APPC recommend to Senate the discontinuance of the Family Child Care certificate program in the Faculty of Access and Continuing Education effective immediately. Eric/2nd Emilio

DISCUSSION:

There was consensus among the committee members to approve the discontinuation of this program, noting the following:

- The program has been in suspension and has not had any student enrolment or interest since 2015.
- The Child Youth and Family Studies department was consulted and recommended discontinuance as industry standards do not require a certificate - only 20 hours of training is required.



- Revision of the program was considered, but it was noted that there are other options for students to enter a course in the ECE program.
- As there were previous offerings in the Seabird community, a question was raised about consultation with Seabird and about options for that community if this program is discontinued. It was suggested that there are other ways to achieve the same ends and that Seabird students (like all students) have the option of registering in an ECE regular course, which they can attend at UFV or could be offered in the community at Seabird College if requested. This would give them at least the required 20 hours. It was also noted that the partner would be informed should they inquire, in future, about this discontinued credential.

- Are there other initiatives that APPC could start that aren't covered by other committees?

Some of the current key things APPC advises on are; concept papers, program reviews, program proposals, program discontinuance, and program suspensions.
