Memo and documents supporting the revised process and procedures were distributed and an overview of the new process and procedures was given. The new process would align with other institutions and the Ministry requirements while improving efficiency throughout the UFV approvals process.

Discussion and notes:

- Discussion was had regarding the Stage 1 Proposal that is to be approved by the Senate Budget Committee (SBC). It was suggested that APPC be involved in some capacity in this stage in order to review the complete Stage 1 proposal for non-budget related content before Ministry submission, noting that the new procedure states that APPC would no longer approve the Full Program Proposal (Stage 2) and in the rare case that SBC would reject the proposal
- It was noted that the new concept paper template includes the social and economic benefits and that Stage 1 just includes more details and that all of the degree quality standards will be fully addressed by going through UEC, GSC, etc.
- It was noted that the concept papers will still be reviewed by Deans and Faculty Councils and stage Stage 1 and 2 proposals will be sent to APPC for information and can be brought into discussion at any time
- Stage 1 is an overall fuller demonstration of the Concept Paper
- Other suggestions were made to streamline the process and procedures
- Committee consensus agrees that the new process seems logical that we seek Ministry approval before Stage 2 is complete

For the proposed Chemistry honours degree, please find attached the program proposal, Budget Analysis Part A, and budget memo in lieu of Budget Analysis Part B.

On May 24, 2019, UEC voted to recommend the Chemistry honours for APPC approval (see attached memo).

On October 17, 2019, SBC reviewed the proposal and budget analysis and voted to recommend the Chemistry honours for approval to APPC (see attached memo).

Program Summary:

The Chemistry honours degree will provide exceptional students with an option for a more rigorous, research-intensive degree option that provides better preparation for graduate school. In comparison to the existing Chemistry major program, the Chemistry honours program requires more credits overall, and the completion of an original research project and undergraduate thesis (CHEM 499). All third year courses required in the major program are also required in the honours program, with the addition of a required introductory course in biochemistry (CHEM 350). An introductory biochemistry requirement will provide honours students with greater breadth of knowledge within chemistry as well as a better appreciation for the increasingly interdisciplinary nature of modern scientific research and practice.

Concept Paper:

A concept paper is not required for a new honours program in a field in which a major or degree is already approved.

At its October 17, 2019 meeting, the Senate Budget Committee reviewed the Chemistry Honours program proposal. Jason Thomas, Program Working Group Chair, and Bruce Kirkley, Associate Director, Program Development & Quality Assurance, provided an overview of the program proposal and addressed questions from the committee. The following comments were noted:

- The proposed program uses existing courses offered to fulfill program requirements with the exception of one new required course: CHEM 410: Honours Research and Thesis, which will run as a directed studies and will not have significant budgetary impact.
- No additional resources are required for the program, and space and equipment needs are the same as those already available and in use for the existing Chemistry major program.
- Currently, Chemistry is the only science that does not have an honours program at UFV. The program is intended to provide students with a competitive edge for admission to grad programs and is anticipated to generate three to five honours graduates per year.
- There is no significant budgetary impact expected.

PROGRAM DISCONTINUANCE

The Certificate in Extended Studies in Child and Youth Care: Child Protection Specialization allows students who have completed the Bachelor of Arts in Child and Youth Care to complete additional work to meet the requirements for the Child Protection specialization. However, the Extended Studies Framework was discontinued in 2016, having been replaced by the Subsequent and Concurrent Bachelor Degree Policy (98). The new policy allows for students to complete a "higher degree option" such as the Child Protection specialization under Regulation (f), as follows:

A UFV graduate may be permitted to take the courses to complete the requirements of a higher degree option in the same discipline (e.g., a major following a minor) provided the option is available within the same degree. Upon completion, a notation will be made on the transcript that the requirements of the higher option were completed. No adjustment will be made to the degree awarded.

2) The Child, Youth, and Family Studies department and the Dean's Office, Faculty of Professional Studies have been consulted, with consensus that the extended studies certificate should be discontinued, and the Child Protection specialization section of the calendar revised as follows: "Students who have completed the Bachelor of Arts in Child and Youth Care can subsequently apply for and receive the Child Protection specialization by completing any additional requirements for the program." 3. Rationale for change(s): The Certificate of Extended Studies in Child and Youth Care: Child Protection Specialization will need to be discontinued, given that the Extended Studies Framework was discontinued in 2016, having been replaced by the Subsequent & Concurrent Bachelor Degree policy (98) and the revised Credentials policy (64).

For the Child Protection Specialization, since it is an option in the BA (CYC), regulation (f) in the Subsequent and Concurrent Bachelor degree applies, and therefore students who have finished the BA can go on to complete additional requirements for the Child Protection specialization, noted on their transcripts.

The final paragraph in the calendar copy for the Child Protection specialization could be revised to the following:

Students who have completed the Bachelor of Arts in Child and Youth Care can subsequently complete the additional requirements needed to meet the Child Protection specialization and will have the specialization recognized with a notation on their transcripts.

4. Transition plan: The credential will be discontinued effective September 2020. Any students currently enrolled in the program will be allowed to complete the certificate. Since the ability to complete the Child Protection specialization is already available to students through the provisions of the Subsequent and Concurrent Bachelor Degree Policy (98), any students who wish to apply for the extended studies certificate should be redirected to apply for the specialization, effective immediately.


Re: Amended procedures for proposed new program development process

In response to the feedback received at the October meeting of APPC, the Program Development and Quality Assurance office has amended the proposed revisions to UFV's process and procedures for the development and approval of new degree programs at both the undergraduate and graduate level. With the amended process, the Stage 1 for new degree programs will go to both APPC and SBC in the same month. Both committees will verify that the Stage 1 for proposals effectively addresses the criteria set forth in the program's Concept Paper with respect to the standards required by the Ministry. APPC will focus on criteria related to academic matters (i.e. Institutional Mandate, Social and Economic Benefit, System Coordination, and Student Outcomes). SBC will focus on criteria related to financial viability (i.e. Institutional Capacity, Labour Market Outlook, Program Duplication, and Student Demand). Both committees must verify the Stage 1 before it can be forwarded for Ministry review. Both committees will also have the option to send the Stage 1 back to Program Working Groups with requests for improvements, which will need to be addressed and the Stage 1 resubmitted for verification. Flowcharts showing the amended process are attached.

As presented at the October meeting, Senate giving responsibility to its standing committees to verify new program proposals at Stage 1 and Stage 2 will ensure both components are reviewed internally by committees (currently only the Stage 2 is reviewed), and will also significantly expedite UFV's internal program approval process. Given the respective roles of the APPC and SBC, it makes sense for these two committees to verify that the Stage 1 for proposals addresses the criteria as set forth in the concept paper, prior to submission to the Ministry. Similarly, since the role of both UEC and GSC is to assure that new program proposals effectively address Stage 2 degree quality standards, it makes sense for Senate to give responsibility to UEC and GSC to verify the Stage 2 proposal, prior to submission to the Ministry.

MOTION: That the Academic Planning and Priorities Committee supports Senate giving responsibility to the Academic Planning and Priorities Committee and Senate Budget Committee to verify that the Stage 1 for new program proposals addresses the required standards and criteria, prior to submission to the Ministry.
